

MARKET OVERVIEW

NEPSE continued its down trend on Tuesday, reporting a fall of 2.23 points, closing at 1258.66 level. Market participants was witnessed further lowering as Turnover, Share Volume and Transactions all decreased by 10.93%, 10.66% and 12.17% respectively. The trade of 177 scripts led to a turnover of only Rs. 35.94 crores. Throughout the day, market traded at the range of 1263.56 to 1258.36. Sensitive and Sensitive Float posted a marginal gain of 0.03 and 0.17 points respectively while Float fell down by 0.08 points.

Three Sub-indices Banking, Microfinance and Development Bank closed green on the day making a gain of 0.44, 4.85 and 1.46 points respectively. Remaining Sub-Indices closed Red. Major losing sectors were Life Insurance, Non-life Insurance and Manu & Pro. that registered the loss of 50.41, 28.35 and 21.6 points respectively.

MHNL, CHCL and RRHP outperformed their respective sectors while SMATA, PMHPL and NHDL underperformed the most in comparison to their respective sectors. RRHP, TRH and AKPL were the most volatile stocks. MLBPO, KSBBL and GUFL traded closest to their 52 week high whereas VLBS, MLBBL and MSMBS traded closest to their 52 week low.

Following the notice by TRH to NEPSE regarding the suspension of any reservation in the Hotel due to protest by the employees and Akhil Nepal Hotel Casino and Restaurant Employee Organization, the effects has been seen on the secondary trade of the company stock. On Wednesday, the stock was the most traded one where it closed at Rs.312 losing Rs.9 on the day.

- ➡ Himal Dolkha Hydropower Company Ltd. issuing 16 lakhs units IPO to the locals of project affected area of Illam district.


