- **Market fell by a marginal 3.03 points on Wednesday;** NEPSE Index closed at 1131.53 level.
- **Sensitive**, Float and Sensitive Float Index all closed Red falling by 0.71, 0.26 and 0.32 points respectively.
- **KKHC** hit positive circuit at the end of the day gaining by 9.43%. Whereas, TMDBL remained the top loser that lost by 6.96%.
- **BOKL** is calling its shareholders to attend 25<sup>th</sup> AGM on 30<sup>th</sup> Ashwin. The main agenda of the AGM is to issue 6% bonus shares and 11% cash dividend. The book closure date for the same is set at 16<sup>th</sup> Ashwin.


