



- Market opened the week's trade with a bearish candle. NEPSE closed at 1125.14 level losing 4.66 points.
- Sensitive, Float and Sensitive Float Index all closed Red falling by 0.98, 0.31 and 0.4 points respectively.
- AKJCL was the top gainer for the day that gained by 3.77% while HURJA reported as the top loser that lost by 8.04%.
- 12% ICFC Finance Limited Debenture 2083 worth Rs. 20 crores was assigned CARENP BBB- ratings by CARE Ratings Nepal.
- TKMCDB propose to distribute 12% bonus share and cash dividend for tax purposes to its shareholders.
- Adjusted Price for 5% bonus shares of MBL is set at Rs. 231.00
- NBL appoints Mr. Krishna Bahadur Adhikari as the CEO
- NLBBLPO set the cutoff price for the auctioned shares at Rs. 221.10. Unsold 85,300 units is to be placed in auction soon.


